- Each share of the Issuer's preferred stock is convertible on a one-to-one basis into shares of the Issuer's common stock at the holder's election and has no expiration date. The preferred stock will automatically convert into common stock upon the closing of the Issuer's initial public offering.
- The option is vested and exercisable as to 115,156 shares, and the remaining shares will vest and become exercisable in equal monthly installments until May 3, 2022.
- The option is vested and exercisable as to 5,573 shares, and the remaining shares will vest and become exercisable in equal monthly installments until March 12, 2023.
- The option is vested and exercisable as to 1,393 shares, and the remaining shares will vest and become exercisable in equal monthly installments until January 17, 2024.
- The restricted stock unit vests on March 12, 2023.
